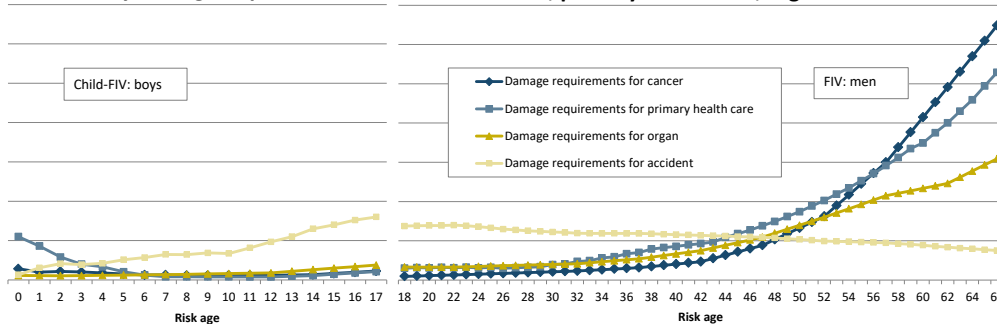
Driver of Innovation in the Casualty Business

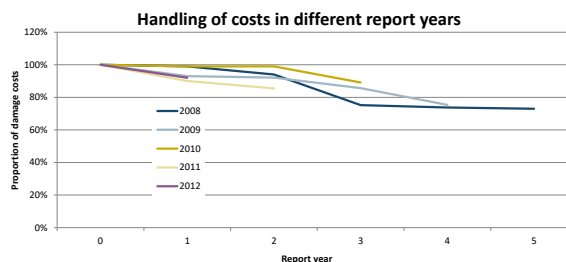
