

Data pool for property/casualty insurers

For significant actuarial statistics

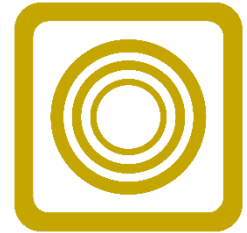
Due to a portfolio of limited size, many insurers have disadvantages as they cannot assess their risks and profitability like big companies. As a rule internal company statistics only have limited significance for an assessment of the company's underwriting risk.

Since 2011 Meyerthole Siems Kohlruss (MSK) has operated a data pool for the sections household, homeowner's, and accident insurance in Austria. In the pool, individual contract data are collected from a number of companies. The data are evaluated with actuarial methods. The resulting statistics can be compared to those of market leaders.

Currently six insurers with a market share of around 16 per cent in household insurance are participating in the pool.

Detect risks early, increase potentials – benefits from the pool

- > Enhancement of data quality: By means of a detailed assessment, the plausibility of the company's data is checked. Potential errors are detected early.
- > Checking the reliability: By comparing the number of new policies, of cancellation quota, and claims ratio, the reliability of the portfolio is analysed by checking its profitability.
- > Analysis of distribution channels: The comparison between results of different distribution channels – for instance related to claims experience, cancellation, and new contracts – offers information on its efficiency.
- > New horizons: Data analyses according to special groups - for instance regions, no-claims duration etc. - offer new horizons for product development and pricing.
